1. Name of the Trust: This trust is called Islamic Guidance Trust and this nomenclature shall not be changed, altered or mitegated in any way so long as this trust is in force.

2. Transfer. We, do, hereby grant, set apart and appoint the funds described in the schedule in Trust and transfer them to the Treasurer of the Board of Trustees, M.K. Abdul Karim, on behalf of this trust as constituted under clauses 4 & 6 of this deed.
3. Purposes of the Trust: The following are the purposes for which trust is established;
- a) To foster and propagate the true teachings of Islam among the members of the Muslim Community in particular and the general Public at large.
  - b) To facilitate the Muslim community for a Islamic cultural renaissance by constantly propagating among them the true spirit and meaning of the Quranic teachings and injunctions.
  - c) To establish institutions like Madarasas, Schools, Colleges, Study classes and Hostels etc., for the welfare of the people irrespective of the communities as decided by the Board of Trustees.
  - d) To assist the weaker sections of the community by offering reasonable opportunity for their development in all the spheres of life.
  - e) To encourage and promote co-operation and brotherhood with other communities of India by all possible means granted by Islam.
  - f) To establish centres for Seminars, Study circles, lectures on topics of National and international importance.
  - g) To assist and promote all social and national causes as decided by the board of trustees.

5. Duration of the Board: The Board of trustees appointed hereby shall be a permanent board of trustees and any vacancy in the Board occasioned by death filled by nominating any Muslim person from outside by the remaining Trustees.

6. Officials of the Board. The Board shall have a chairman, a Vice-Chairman, a Secretary, a Joint Secretary, a Treasurer, and a legal advisor. We hereby fix and appoint Mr. P. K. Muhammed Trustee No.1, E. Muhammed, Trustee No.2, K. P. Yoosuf, Trustee No.5, P. S. Kunjumoiden, Trustee No. 7, M. K. Abdul Karim, Trustee No.6, Advocate M. Fareed Sahib, Trustee No.3, as Chair-man, Vice-Chairman, Secretary, Joint Secretary, Treasurer, and Legal Advisor, respectively of the Board, for 3 (three) years and thereafter, the Board shall elect the officials from among them. The term of the office of the officials is three years, but all lawful actions taken, matters decided and functions performed by the existing officials during the period of the expiry of their term of office and new election shall be binding on the Board unless otherwise formed by the Board with gross negligence irresponsibility or mala-fides.

7. Functions of the Chairman. The Chairman will preside over the Board meetings, supervise the functionings of the Board and its officials, give necessary directions to the proper administration of the Trust and shall represent the Board in both the civil and criminal proceedings and in all offices of the Central and State Governments and before all the authorities under the Sales-Tax, Income-Tax and Land Reforms acts and before Municipalities, Panchayats, and Corporations etc. as long as otherwise decided by the Board.

8. Functions of the Vice-Chairman. The Vice Chairman shall have all the powers of the Chairman in his absence and only when he gives authority in working in his presence.

9. Functions of the Secretary. The Secretary of the Board shall perform the day to day administration of this Trust, maintain proper accounts of income and expenditure, call the Board meetings execute the decisions and directions of the Board and keep all the papers and documents of the board in safe custody but with full right and liberty to any of the trustees to inspect and copy down them on one week's notice. The Secretary can keep in hand cash only up to Rs.250/= the excess being handed over to the treasurer.

Functions of the Joint-Secretary. The Joint-Secretary shall perform all the functions of the Secretary only when he is authorised by the secretary in writing.










- 11. Functions of the Treasurer: The treasurer shall keep the funds of the Trust and keep accounts of receipts and payments. The treasurer shall pay amounts only at the direction of either the Chairman or the Secretary or both in writing and none else.
- 12. Office of the Board: The office of the Board shall be at Erattupetta, but the Board shall have power to change the location of the office to any other parts of the District of Kottayam or open sub-offices at such other places as it deems fit outside the District.
- 13. Functions of the Board: (a) The board of Trustees shall give and administer this trust properties to the best interests of the trust and for the purposes of this trust declared herein and discharge its duties with utmost care and efficiency.
- 14. Powers of the Board: (a) The Board shall appoint the necessary staff employees and other officials for the functions of the Trust and shall have power to decide all matters relating to such appointments and other relevant factors connecting the same.  
 (b) The Board may approve an annual budget for the ensuing financial year categorising the heads of income and expenditure. But, The Board is at liberty to expend the unspent amount of one category to the other according to importance, urgency and circumstances, the financial year being April to March.  
 (c) The Board shall have power to accept the Trusteeship, or Managements of any other trusts, wakfs, Association or organisations or endowments ~~(and such Trusts, Wakfs, Associations, Organisations or endowments)~~ shall be the provisions of this deed.  
 (d) The Board shall have power to acquire, accept or receive any endowments, gifts, grants or donations "Sadakas or Zakats" movable or immovable made to this trust by assignment or other wise by any individual groups, families, organisations, or associations whether incorporated or not, by any Government, Central or State and all such endowments, gifts, grants and donations shall be considered as part of this Trust properties and their managements income or expenditure shall be unconditionally carried on and used for under the provisions of this deed.  
 (e) The Board shall not have power to sell the properties of the trust or any part thereof except in case unavoidable necessity and circumstances for purchasing other morethan beneficial properties, movable or immovable. But, the Board shall have power to pawn,

pledge or mortgage the Trust properties to raise funds for the purposes stated in clause (e) above and no such pawn, pledge mortgage or sale shall be valid unless made after the decision of the board by 2/3rd of its existing strength.

(f) The Board shall deposit the funds of the trust in excess of Rs.250/= in such bank or banks as decided by the Board in the name of the Trust and unless and until otherwise decided by the Board the Chairman and the Secretary can Jointly negotiate and operate on such accounts by issuing jointly signed cheques or bills.

15. Sitting and Sitting allowances. The Board shall sit in session at least once in three (3) months and the members are eligible for sitting allowance, bata or travelling allowance etc. in such custom and manner as and when decided by the Board. The Secretary shall submit before the Board in every sitting a working report of the Trust as on the day.
16. Notice of sitting. (a) The Secretary shall give minimum Seven(7) days notice to the members of the Board for its ordinary sitting but in emergency cases the notice period can be reduced to 24 hours. (b) In case the Secretary fails to call the Board for its ordinary session, the Chairman shall have power to call the Board and hold its session. (c) If the Secretary or the Chairman fails to call the session of the Board for a continuous period of one year, 25 (Twentyfive) members of the Board can issue notice to the Secretary or Chairman demanding to call the Board meeting with 15 (fifteen) days and noting the points to be discussed in the Board meeting and if the Secretary or the Chairman does not comply with terms of the said notice, the said 25 members themselves may call the board meeting with an agenda and decide the matters accordingly.
17. Quorum and Majority: (a) The quorum of the Board in session shall be one third (1/3) of the strength of the existing members and all the decisions of the Board must be in writing and by the majority of the members sitting. The Majority decision of the Board shall not be questioned by any member of the board, except in a court of law, but the Board shall have power at its discretion to review its own decisions. (b) In case any Board meeting happend to be adjourned for want of quorum, the next meeting, if called within a month, can be held irreespective of the quorum, but attended to by at least ten members.

- 18. Casting Vote of the Chairman. When the Board in session is equally decided in voting, the Chairman will have the right of casting vote (besides his ordinary vote) and the finality of the matter in dispute will be decided accordingly. This right of casting vote if available to the chairman of the Board and not to any other person authorised by him or presiding over the person in his absence.
- 19. Enlargement of the Board. According to the circumstances a necessity of occasions are felt by Board, the Board is empowered and authorised to enlarge its strength by nominating as many muslim members from outside as it thinks fit;
- 20. Disciplinary action: Any Trustee or Trustees whose acts, omissions or behaviour are found detrimental to the interest of this trust may be suspended or dismissed by the Board by a resolution approved by a 2/3rd majority of the total strength of the existing Board in case of no reply to the show cause notice given to such Trustee or Trustees or in the case of reply which is unsatisfactory.
- 21. Rules and Regulations: The Board by a majority of 75 % of its members may frame necessary rules and regulations helpful and ameliorative to the smooth and effective conduct , ruling and management of the Trust, but such rules and regulations shall in no way be derogative or circumventing the purposes of this Trust.
- 22. Auditing: The accounts of the trust shall be audited by duly qualified accountants, but the Board can also get the accounts audited by appointing other persons then qualified according as the circumstances.
- 23. Act applicable. This trust is to be governed by the provisions of the Indian Trust Act (Act 11 of 1882).
- 24. Irrevokability: This trust is an irrevokable Trust and neither we nor our descendants have any right or authority to revoke it. But the Board if decided by 75% of its members, shall have power to associate or amalgamate with other trusts constituted for similar purposes.
- 25. Valuated: This Trust is valued at Rs.500/=(Rs.Five hundred)only.
